The 2021 Brighter Future Fund (BFF) aims to provide grants to BIPOC, LGBTQIA+, and women farmers across the nation to uplift, support, recognize and amplify the diversity of farms and farmers. These grants will enable participants to enhance viability, access land, and increase resilience.

Applications will be reviewed on a rolling basis beginning November 2021. Applications must be submitted electronically through our grant portal.


